

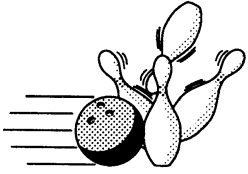

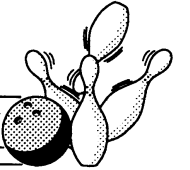

TOURNAMENT RULES

1. Sanctioned by USBC and open to all members.
2. Entering **"sanctioned"** average:
 - a. Must use highest year end book average with 21 games from 2024-2025 season or highest mid season average with 21 games as of Dec. 31, 2025 (whatever is highest) - or tournament avg. - See tournament director.
 - b. All others will bowl scratch.
 - c. Rule 319c will apply & 319D & E will not apply
 - d. WRITTEN AVERAGE VERIFICATION for out of town bowlers is required at time of entry.
3. Handicap will be based on 90% of 235.
4. Bowlers can compete in all shifts when available. May cash only once with the same partner.
5. Tournament starts February 14, 2026 and entries close at the start of the last shift on Feb 22, 2026.
6. Prize fund will be returned 100%. At least 1-10 ratio. 75% going to handicap, 25% going to scratch
7. Penalty for reporting incorrect averages may result in DISQUALIFICATION. Tournament manager will be able to verify and adjust any wrong averages up to March 1, 2026.
8. Check in 20 minutes prior or spot may be forfeited.
9. All tournament play will be governed by USBC rules and discrepancies shall be decided by tournament officials.
10. Any Ties - money for those spots will be divided equally.
11. Any protests must be turned into tournament director by March 1, 2026.

TOURNAMENT FORMAT

Teams will bowl three games taking scratch total plus handicap for a score. Final standings shall be determined after all teams have completed all shifts, at which time top scores and payout will be posted. Handicap and scratch payouts to be near March 15, 2026.
